#### **Accounting and Finance Report**

Bob Brown presented finances for the start of the new school year through July 31, 2014. Cash flow is anticipated to decline because of bond interest payments and 90-day cash reserve to increase credit payments to \$46,000. Additional funds for Title I and Special Education entitlements should arrive in November/December to assist with cash flow. We are within budget. A concern was raised about the removal of the modular buildings that were already in existence when DHPA moved. The cost will be approximately \$25,000 for removal because of the lease option we have.
